### 3. 7<sup>th</sup> meeting of the UfM Working Group on Blue Economy (15<sup>th</sup> September, Online)

The 7th WG aimed at recapping the state of art of the Ministerial process and the ongoing Blue Economy initiatives and activities; as well as to address the impacts of the COVID crisis on the specific blue economy sector/s and identify more precise concrete actions for the years to come. ### 4. BlueMED: Bluemed Preliminary Implementation Plan (June, 2020)

The BlueMed Research and Innovation Initiative is formally joined by 16 EU and non-EU Mediterranean countries and steered by the EuroMediterranean Group of Senior Officials BlueMed Working Group (GSO BlueMed WG), co-chaired by the European Commission and the co-chair of the Union of the Mediterranean (currently Jordan) and supported by the Secretariat of the Union of the Mediterranean. **Read the full Preliminary Implementation Plan [here](#).**



### 5. WestMED: Towards a Maritime Innovation Technologies Platform

WestMED Initiative organized a series of Hackathon type meetings amongst which Hackathon n4 discussed and assessed the potential for a Mediterranean-wide Maritime Innovation Technologies Platform (Med-MIT) or similar actions and/or projects that could allow for greater cooperation between clusters, research/technological centres, institutions and sectorial actors. ### 6. EUSAIR: Mediterranean Coast and Macro-regional Strategies Week 2020 (September, 2020).

The fifth Mediterranean Coast and Macro-Regional Strategies Week is one of the key events during Slovenia's Presidency of the EU Strategy for the Adriatic and Ionian Region (EUSAIR). The event aimed to raise awareness about the sea, its coast and the natural and economic potential it boasts, and outlines the risks facing the sea and the coast as a result of natural phenomena and human activities. ### 7. European Green Deal – Research & Innovation Call – Currently Open - €1 billion investment in green and digital transition

The European Commission has launched a €1 billion call for research and innovation projects that respond to the climate crisis and help protect Europe's unique ecosystems and biodiversity. The projects funded under this call are expected to deliver results in ten different areas. The deadline for submissions is 26 January 2021, with selected projects expected to start in autumn 2021. ### 8. UfM: Reducing pressure on oceans and seas and creating the conditions for a sustainable blue economy

The UfM participated in the EU International Ocean Governance Forum, launched by the European Commission in association with the European External Action Service to provide a platform for dialogue on ocean challenges and governance solutions. The International Ocean Governance (IOG) Forum took place online on 23-24 of April to further strengthen international ocean governance for the sustainable use of oceans and seas and the shift to the blue economy. With the participation of the UfM Deputy Secretary General, Isidro González Afonso and UfM Head of Sector, Alessandra Sensi, the core of the debate was the degradation of marine ecosystems and the related economic and social impacts of activities linked to the seas, like the supply of food and tourism. 
## 9. UfM: Strengthening collaboration to tackle pollution in the Mediterranean

The UfM strengthens collaborative efforts to address the impacts of pollution together with the UN Environment Program / Mediterranean Action Plan (UNEP/MAP). The UfM participated at the UNEP 21st Meeting of the Members of the Steering Committee of Mediterranean Commission on Sustainable Development on 13-14 May 2020. The discussions focused on marine litter, biodiversity, marine protected areas and coastal management, as well as a proposal to make the Mediterranean Sea, as a whole, an Emission Control Area for sulphur oxides emitted by oil fuel of ships. ## 10. Updated analysis of the impacts of the COVID-19 crisis on fisheries and aquaculture in the Mediterranean and the Black Sea

Since early March 2020, the COVID-19 pandemic has disrupted business as usual around the world with severe consequences affecting most industries in the Mediterranean and Black Sea region, not least of which, the fisheries and aquaculture sectors. Two months after the [preliminary analysis](#) carried out by the General Fisheries Commission for the Mediterranean, which covered the critical early phase of the crisis, from March to April 2020, the GFCM is publishing: Fisheries and aquaculture in the Mediterranean and the Black Sea An updated analysis of the impacts of the COVID-19 crisis. ## 11. INTERREG MED BLUE GROWTH COMMUNITY gathers key stakeholders to transfer tools

On July 27th 2020, the Blue Growth Community (BGC) organised its 2nd Advisory Board meeting (on-line event) with a high participation -more than 120 registered persons and around 65 permanent attending participants- among the BGC members, MED Blue Growth projects and relevant stakeholders included. This on-line meeting was the occasion for updating the Community members on the project's progress, explaining the transferring process towards capitalisation of the BGC modular projects' outputs and the role of the Community in this process. Besides, BGC partners highlighted the importance of the "[marina-platform](#)", as an interactive space for working together and a powerful tool for the Advisory Board's activities. ## 12. INTERREG MED BLUE BIO MED: A project to promote better governance of blue bioeconomy innovation policies

BLUE BIO MED is one of the two strategic projects funded under Interreg MED Axis 4 on Governance (PANORAMED) recently launched that focus on blue bioeconomy. The project promotes the transformation of Mediterranean blue bioeconomy field toward sustainable development goals through innovation. It supports better governance of innovation policies bridging the transnational governance frameworks active in the Mediterranean area (i.e. UfM, UNEP-MAP, EUSAIR, WestMed, Bluemed Initiative, etc.) with the territorial – regional/national – policy making, assuming the Agenda 2030 Sustainable Development Goals (SDGs) as the common reference grid. CPMR will be highly involved in the project's communication activities, as coordinator of the related work package, with a focus on sharing information on blue bioeconomy. [Learn more](#)

The call is aimed at Enabling Research in Plastics in a Circular Economy Context, it is intended to support applicant entities seeking to escalate the activities to explore new ideas, methods and innovations that can bring changes in the manufacturing/imports/distribution, consumption patterns and life cycle of



plastics. This will enable the participants to generate their ideas and carry out the necessary preparatory activities that may lead to an enhanced project proposal for Horizon Europe calls based on any actions they wish to carry out locally and may include activities overseas. [Learn more](#)


### 1. WEBINAR: Impacts of the COVID-19 pandemic on Ports and Maritime Transport in the Mediterranean Region

The Union for the Mediterranean (UfM) and the MEDports Association, hosted an online Webinar on the “Impacts of the COVID-19 pandemic on Ports and Maritime Transport in the Mediterranean Region” on 27 May 2020, from 10:00 to 13:00. The meeting brought together representatives from port authorities of the Mediterranean basin, shipping lines and other maritime-related transport companies, along with sectoral international and regional organisations, the European Commission and National transport administrations. ### 2. New publication: Reaching the 2020 Horizon: 14 years of Mediterranean cooperation on Environment.

The 'Horizon 2020 Initiative' (2007 - 2020) has been a joint effort to substantially reduce pollution in the Mediterranean by tackling the sources that are said to account for around 80% of the overall pollution of the Mediterranean Sea: municipal solid waste, urban waste water and industrial pollution. The initial frame of action and scope progressively expanded since its mid-way point in 2014, to integrate approaches and actions in support of pollution prevention and the region's transition towards a green economy. 
### 3. BLUEMED e-training course: Understanding and Acting for a Healthy Plastic Free Mediterranean Sea (16<sup>th</sup> June-21<sup>st</sup> July 2020, online)

The BlueMed Initiative delivered the e-training course on Understanding and acting for a healthy plastic free Mediterranean Sea, organized in the framework of the Pilot Action Healthy Plastic-free Mediterranean Sea. The course brought together experts working on Marine Litter and the Blue-economy in order to share knowledge, showcase best practices and suggest methods enabling more sustainable blue jobs in the framework of the circular economy strategy, taking into due consideration education for sustainable development and citizen science. #### **6. 2020 Blue Economy Report: Blue sectors contribute to the recovery and pave way for EU Green Deal**

The EU Blue Economy Report 2020 was published in June 2020. It provides an overview of the performance of the EU economic sectors related to oceans and the coastal environment. With a turnover of €750 billion in 2018, the EU blue economy is in good health. There were also 5 million people working in the blue economy sector in 2018, representing a significant increase of 11.6% compared to the year before. [Learn more](#)
