# HEALTHY GATEWAYS - contribution to restarting cruise operations in Europe & worldwide



January 2020:  
First version **European guidance supporting ship operators** and competent authorities for COVID-19 preparedness and response

June 2020:  
First version **European guidance supporting restart of cruise operations** after lifting restrictive measures (followed by ferries and inland river cruises)

- HEALTHY GATEWAYS guidance implemented by EU MS, adopted by the maritime transport industry & ports → contributed to **timely** and **successful** restart of cruise operations in 2020-2021
- Evidenced as cruise travel resumed in Europe (summers of 2020 & 2021) without major outbreaks
- In other countries cruise travel resumed months later (e.g. USA under CDC Framework for Conditional Sailing Order)



**HEALTHY GATEWAYS guidance provided framework for shared protocols, to achieve common standards for COVID-19 response at ports & on board cruise ships in EU MS**

# HEALTHY GATEWAYS - response to COVID-19 pandemic



Activated emergency mode to support **governmental authorities' response** at points of entry and the **transport sector's resumption** of operations

- At European Commission request, 15+ evidence-based guidance documents developed on COVID-19 preparedness and response for all transport sectors  
→ focus on **maritime** → focus on **cruise travel** and **ports**
- Supported **re-opening of cruise ports after the pandemic in MED countries (EU & non-EU), ensuring common cruise port protocols**
- Provided **rapid consults** to European Commission agencies, transport industry and EU MS on issues related to COVID-19 at points of entry and transport means
- Produced **training and exercise materials** to support capacity-building specific to COVID-19 preparedness and response

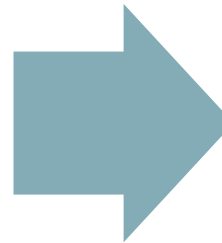
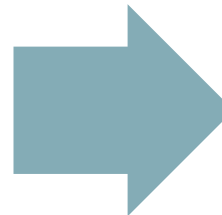
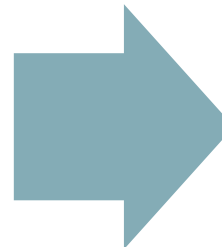


## UfM Ministerial declaration on Sustainable Blue Economy (§57)\*

a. Promote policy coordination, stakeholder collaboration and cooperation mechanisms to strengthen the resilience of the tourism sector in the Mediterranean

b. Develop comprehensive monitoring, evaluation and statistics schemes and promote the digitalization of the sector

f. Promote fiscal and investment policies to support sustainable coastal and marine tourism



## Proposal objectives

Coordinated stakeholder collaboration and cooperation mechanisms, to prevent and respond to extraordinary emergencies related to cruise tourism in MED

Utilization of common databases by all MED countries for information exchange on preventing and responding to extraordinary emergencies

Expand the EU network/establish a MED network to support sustainable coastal and marine tourism, uninterrupted by extraordinary emergencies such as COVID-19

## 1. Resuming cruise tourism

- Contributing to regional economic recovery from the COVID-19 pandemic
- Putting people back to work





# Why MED cooperation on cruise tourism?



## 2. Current gaps that jeopardize full recovery

- Different/variable response protocols to extraordinary events in Mediterranean countries
- COVID-19 pandemic demonstrated gaps in response capacities of governments, port authorities and the cruise industry
- Gaps still exist, outbreaks still occur and some cruises have been canceled due to outbreaks in 2022
- Challenges with information exchange and lack of formal communication channels





## 3. Preparing for current & future emergencies

- Lessons learned from the pandemic should be considered to:
  - prevent COVID-19 in the short term
  - get prepared for future extraordinary emergencies, preventing any potential future devastating consequences



# Why MED cooperation on cruise tourism sector?



## 4. A common approach in MED is the only way

- Ships sail rapidly between countries
- The same extraordinary event on board a cruise ship should be managed in different ports in the same itinerary, by different authorities
- A common MED approach is the only effective way to deal with extraordinary emergency events on cruise ships and can support:
  - Avoiding contradicting requirements from port-to-port
  - Avoiding border closures and cancellation of cruise ship calls





## 5. Ensuring uninterrupted cruise tourism

Cruise ships can

- **effectively deal with extraordinary** events only if all countries in the itinerary apply measures in a **harmonized** and **coordinated way**



# What we propose ...



1. Common protocols for:
  - Preparedness and management of extraordinary events on board **cruise ships and ferries**, to ensure compatibility of protocols when ships sail between countries
  - Standards for preventing and responding to extraordinary events
2. **Safeguarding healthy tourism** and cruising throughout the region



3. Ensuring cooperation for the application of common protocols for **all types of ships** between countries in the region
4. Common protocols for **port responses** to extraordinary emergency events on cruise ships



5. Operation of a **Common Database**, including communication network platform for information exchange between ports and national authorities from different MED countries, in case of extraordinary events on board cruise ships
6. Conduct of **cruise ship inspections** using common standards



7. **Training and exercises** for event management on board ships, to increase response capacities and promote a harmonized approach

- Expanding the existing EU network for prevention, monitoring and response to extraordinary emergency events to **ALL MED COUNTRIES**

## HUBS OF EXCELLENCE

- Establishment of hubs of excellence in 4 MED countries  
**MED North, East, West, South**

## Network HQ

- Establishment of the network's HQ secretariat service for maintenance of information systems etc. (e.g. Greece)
