### **EU MISSION: RESTORE OUR OCEAN AND WATERS**

## WHAT ARE THE EU MISSIONS?

EU Missions are large-scale initiatives under Horizon Europe designed to tackle major global challenges, such as climate change, cancer, soil health, ocean restoration, and the development of climate-neutral and smart cities. They set clear, time-bound goals and bring together research, policy, and stakeholders to drive innovation and deliver concrete solutions for societal benefit.

### MISSION RESTORE OUR OCEAN AND WATERS BY 2030

The Mission provides a systemic approach to the protection and restoration of the ocean and Europe's seas and waters by 2030, fostering a sustainable marine and freshwater environment.

Driven by research and innovation and aligning with the European Green Deal targets, the Mission is addressing three specific objectives with clear 2030 targets for:

- **Protecting** and **restoring** marine and freshwater ecosystems and biodiversity.
- Preventing and eliminating ocean, sea and water pollution.
- Ensuring a sustainable, carbon-neutral and circular blue economy.

# KEY ACHIEVEMENTS

- To accelerate progress toward achieving the Mission's objectives, four **Mission Lighthouses** have been launched as regional hubs. These hubs structure **cooperation** and drive the development and deployment of **transformative**, **innovative solutions** across the Atlantic and Arctic basins, the Mediterranean
  Sea basin, the Baltic and North Sea basins, and the Danube River basin, including
  the Black Sea.
- The Mission is actively **engaging**, **supporting**, and **mobilising** a diverse range of stakeholders. More than **1,000 actions** have already been endorsed under the **Mission Charter** for Ocean restoration, supported by a budget exceeding **EUR 7.7 billion**. This includes commitments from 179 countries, over 50 regions, and 90 municipalities, and the number continues to grow. The Mission is also mobilising through **public participation initiatives**, including the Blue Parks Community, the Coalition of Island Regions and Waterfront Cities, the Blue School Network and the EU4Ocean Coalition.

- The Mission is funding projects that test and demonstrate innovative approaches and solutions to address its objectives with a cross-basin perspective. Over 200 demonstration sites are already operational under these projects, with more to come.
- The Mission is providing direct support to key communities through tailored technical assessments and feasibility studies for ports, fisheries, and island communities, as well as financial advisory services for innovative Blue Champions.

#### **SUCCESS STORY**

The <u>European Digital Twin of the Ocean</u> (EU DTO) is the bedrock of the Mission that builds on existing infrastructures like <u>Copernicus</u> and <u>EMODnet</u>, highlighting Europe's commitment to developing innovative scientific tools to address the challenges facing our ocean and waters.

Launched in 2022 with EUR 15 million in annual funding, the DTO aims to provide accessible, science-based ocean knowledge to a broad range of users, from policymakers and researchers to businesses, activists, and citizens, through a unified digital framework that transforms data into actionable knowledge. It integrates marine observations, advanced ocean modelling, artificial intelligence, and high-performance computing, offering unprecedented capabilities for marine data exploration, policy-making, and environmental adaptation and mitigation. The platform is expected to achieve full operational status by 2030.



### **ALIGNED AMBITIONS AND SYNERGIES**



The Mission supports the implementation of key EU policies and regulatory initiatives for the ocean, seas, and waters, including the EU Biodiversity Strategy and Nature Restoration Regulation, the EU Action Plan Towards Zero Pollution for Air, Water, and Soil, the European Climate Law, the European Water Resilience Strategy, and the European Ocean Pact. Additionally, it contributes to Europe's sustainable prosperity by driving both green and digital transitions across these vital ecosystems.

The Mission supports SDG 14 by regenerating our oceans and waters and SDG 6 by ensuring the availability and sustainable management of water and sanitation for all, in addition to contributing to achieving most other SDGs, including climate action (SDG13) and the sustainability of cities and communities (SDG11).
