
Country reporting template: aim and objectives

Ministerial Declaration Priorities	Initiatives at national/sub-national level
Food from sea: fisheries and aquaculture	Morocco enforces annual biological rest periods (fishing moratoriums), particularly on its southern
	coasts (Agadir to Cap Blanc), to protect fish stocks, most notably sardines , during their spawning season.
Sustainable, climate-neutral and zero-pollution transport and	-continuous engagement of Morocco in the Blue Ports initiative monitored by FAO.
ports	Though Morocco has not yet officially ratified Annex VI of the MARPOL Convention, which concerns the Prevention of Air Pollution from Ships (including sulfur limits), the country is engaged in activities towards the implementation of this constraining instrument(the entry into force on May 1, 2025 of a Sulphur Oxide
	Emission Control Area (SECA) in the Mediterranean sea.
Coastal and Maritime Tourism	The National Ports Agency (ANP) has launched studies to evaluate and improve services in high-potential segments, including pleasure boating. The objetive is to optimize the quality of port services and strengthen competitiveness.
Marine Renewable Energies	Morocco has officially submitted its third Nationally Determined Contribution (NDC 3.0) to the United Nations Framework Convention on Climate Change (UNFCCC), which sets out a path to reduce greenhouse gas emissions by 53% by 2035 and commits the country to carbon neutrality by 2050.

Maritime safety and security of blue economy activities	-The Royal Navy continues to regularly host naval and bilateral exercises such as "FRONTIÈRE MER" as part of the 5+5 Defense Initiative or exercises with the US Navy and other partners aimed at improving interoperability and port security. - Morocco cooperates regularly with organizations such as the United Nations Office on Drugs and Crime (UNODC), as part of the Global Maritime Crime Programme (GMCP), to strengthen maritime law enforcement (MLE) capabilities on the subject.

Projects at national (and sub-national) level within the implementation of the 2021 UfM Ministerial Declaration on SBE

Ministerial Declaration Priorities	Projects at national/sub-national level
Food from sea: fisheries and aquaculture	 Finalization of the project titled "Support for the Development of Aquaculture Professions in Morocco," which was funded by Norway and the Netherlands and executed by FAO in coordination with the Secretariat of State for Maritime Fisheries and the National Agency for the Development of Aquaculture. The main goal of the project was to develop a skilled workforce and provide technical assistance to aquaculture. Some of the main achievements of the project:
Sustainable, climate-neutral and zero-pollution transport and ports	Inauguration of a ship repair yard in Casablanca for an approximate investment of 2.5 billion MDH (250 million USD), (to revitalize the shipbuilding and repair industry, including a 240-meter dry dock and a lifting platform.
Coastal and Maritime Tourism	Inauguration of a new cruise terminal in Casablanca with an annual capacity of 450,000 passengers, capable of accommodating cruise ships up to 350 meters long. Cost: 720 millions MDH (72 million USD).
Marine Renewable Energies	The Moroccan government preselected five investor consortia to develop six large-scale green hydrogen and derivative projects. Expected total investment: approximately MAD 319 billion (around \$32.8 billion). Scope of the projects: production of derivatives such as green ammonia, e-fuels, and green steel. Origin of investors: national and international companies from the US, Spain, Germany, UAE, China, and Saudi Arabia.
