

The external evaluation



- was foreseen in the Roadmap, in the context of the preparation of a new Ministerial Declaration, expected possibly after 2025
- was a Formative Evaluation: it examined what has been done so far and why, comparing this to the original 2021 Ministerial Declaration and Roadmap. It examined the extent to which the aims and objectives of the Ministerial Declaration remain feasible, appropriate and acceptable
- used the OECD/DAC evaluation criteria of Relevance, Coherence, Effectiveness,
 Efficiency, Impact, Sustainability, Added Value
- serves to provide information in support of the **preparation and identification of the priorities of a subsequent Ministerial Declaration**, and its recommendations
 may serve as a basis for **future political deliberations** on the SBE



Findings per criterion



COHERENCE: The MD is coherent and strategically aligned, supporting shared sustainability goals. Implementation depends on national coordination, balanced capacities and ongoing regional support.

EFFECTIVENESS: The MD has prompted coordinated policies, regional strategies, and national actions, though achievement varies. More work is needed to turn frameworks into transformation.

governance, the Roadmap and EU Programme funding, yet coordination is challenged: uneven implementation and local engagement, fragmented systems.

IMPACT: The MD has sparked regional and subregional projects, fostering cooperation and a shared agenda - though coordination and funding issues remain. **SUSTAINABILITY**: The MD addresses SBE challenges, aligns national efforts with regional goals, sustains its impact via the monitoring system, the Roadmap, and international alignment.

ADDED VALUE: The MD sets a common strategic agenda, boosting regional cooperation, encouraging regional engagement and strengthening synergies, with the UfM promoting cohesion.



Key Take-aways from the Evaluation



The MD ensures that the strategic vision is associated to the Roadmap for results-oriented implementation, with a robust Implementation Plan per priority.

In the future it should maintain the same approach, prioritising high-impact sectors.



Capacity-building should be scaled up, especially for Eastern Mediterranean countries. **Governance** and coordination across regional initiatives should be strengthened, beside broader stakeholder engagement. The MD should address regional disparities by promoting equitable development mechanisms and enhancing cross-basin collaboration.



It is acting as **a catalyst for national reforms:** supporting national action plans and roadmaps as tools for improving coordination and streamlining collaboration across the Mediterranean, relying on other partners and funding mechanisms for implementation



Access to finance should be expanded and simplified, with a central point of reference for funding opportunities. The BlueMedPartnership is the dedicated Blue Economy Fund offering targeted support for scaling sustainable initiatives



The UfM's strategic role **as regional convener and facilitator** can be further reinforced, to align Mediterranean efforts with global frameworks.



Conclusions

While progress has been made in critical sectors, challenges related to funding, regulatory differences, and stakeholder coordination must be addressed

- The 2021 UfM MD on Sustainable Blue Economy continues to be a guiding framework for regional cooperation.
- The role of UfM and initiatives to balance capacities and interests in the Mediterranean are the key to unlocking the full potential of the blue economy.





It is imperative that Mediterranean countries **continue to strengthen cooperation, share resources, and ensure that the Blue Economy remains a driver** for environmental, economic and social transformation across the region.



The current dynamic momentum of the MD is an indication that **funding for the UfMS SBE platform** should not only continue but should be further enhanced.



- (i) as a means of continuing & reinforcing the provision of technical assistance by the UfMS
- (ii) as a means of securing funding for SBE transnational projects per se and thus supporting capacity building and exchange between participating states.
