Through the north-south cooperation, clusters from both shores are now working together and building bridges between ecosystems.

























## Call for Joint Action by Maghreb Maritime Clusters and Beyond

#### The initiative **GOALS** is to:

- Call for Joint Action by Maghreb Maritime Clusters and Beyond
- Accelerate the North-South and South-South cooperation process, fostering stronger regional integration and shared development within the maritime and blue economy sectors.
- Act as a catalyst for achieving the political objectives set by relevant regional initiatives, such as the Union for the Mediterranean Ministerial Declaration on Sustainable Blue Economy and the WestMED Initiative, promoted by the European Union and the Western Mediterranean countries.
  - Development of an engagement plan for the establishment of a Union of Maghreb Maritime Clusters, signed on January 21, 2024, marking a significant milestone toward structured regional cooperation in the maritime sector.
  - Development of a coordination questionnaire aimed at identifying common priorities, specific needs, and potential areas of collaboration among the maritime clusters of the Maghreb countries.
  - Development of a strategic plan for joint action by the Maghreb maritime clusters — Tunisia (2019), Mauritania (2022), Libya (2024), Algeria, and Morocco (in progress) — to strengthen regional governance, competitiveness, and innovation within the blue economy.

## **VISION**: Long-term vision elements

- Making the Maghreb a pioneering region for the sustainable, innovative and inclusive blue economy in the Mediterranean, through strengthened regional cooperation between clusters
- Joining forces of the Maghreb maritime clusters to position the region as a strategic hub for integrated, resilient and attractive maritime development for international investors
- Developing national maritime clusters into a Maghreb cluster to increase the regional impact and international visibility of the blue economy

# The role that should the alliance play in strengthening cooperation between countries in the region and promoting the blue economy

- Encourage the establishment of joint projects between Maghreb countries, by promoting the exchange of resources and expertise
- Facilitate access to international financing for joint blue economy initiatives
- Create cross-border partnerships to share best practices and strengthen cooperation between maritime clusters
- Promote innovation and collaborative research to maximize the impact of maritime clusters
